# Highway Report

The highway supervisor report was read by Mrs. Horan. The highway supervisor has submitted applications to the DEC and Army Corp of Engineers for stream repairs on town grounds. JR has dug up many stackable rocks to cut the cost of the project, but medium size shot rock will still have to be purchased for bank stabilization. Otsego Soil and Water was a great help with the permit process – and now we just have to wait and see if it gets approved. There has been no word on the new truck, the last information was that it is still scheduled for August.

### Planning Board

Lois informed the board of two minor sub-divisions that were approved by the planning board and one that may end up going to the Town of Otego ZBA for resolution. Also, the Zoning Commission is working with Beth and Avery of Coughlin and Gerhart prior to the board meeting for a while to proof the draft zoning document.

The town received notice that Mario Arevalo will be retiring at the end of his term in September. The town will form a committee to replace him in late summer and he has volunteered to help with the process.
