Special Use Permit - Instructions

- 1. A list of Special Use Permit categories can be found in the Zoning Ordinance, available on the town web site.
- 2. Complete applications with the \$75 fee may be submitted to the Town Clerk.
- 3. Name/ address should be for the person applying for the permit and the home address of that person with the phone and email address so that we can contact you if we need to.
- 4. If the special use permit is for location other than that residence, the address of that location needs to be given.
- 5. The Property Tax Map number is required for the location of the Special Use. The Property Tax Map number can be found on the upper right of the General Property tax bill. It is also available from the Town Accessor or the Otsego County web site:
 - a. https://www.otsego county.com/departments/real-property-tax- services/index.php
 - b. Select 'Real Property Lookup'
 - c. On the next page select "Public Access"
 - d. On the 'Otsego County Search" form, fill in at least your name and township
 - e. Select "Tax ID" that goes with your parcel
- 6. A detailed description of your proposal will help the Planning Board.
- 7. Applications will not be considered until complete and must be completed within one year. An application that is not completed within one year will need to be refiled.
- 8. Complete applications need to be submitted at least 10 days before a scheduled Planning Board meeting (third Tuesday of the month) to be placed on the agenda for that month.
- 9. A Public hearing will be scheduled only after an application is complete.
- 10. Limitation and conditions may be placed on the permit by the Planning Board.
- 11. The Code Enforcement /Zoning Officer reserves the right to check the Special Use operation from time to time, within normal business hours.


TOWN OF OTEGO PLANNING BOARD SITE PLAN SAMPLE

SITE PLAN

A site plan is a diagram of the property where the requested action is to take place. It is necessary to include a plot plan for most planning board actions on a parcel to demonstrate compliance with such things as set back requirements from property lines and roadways, distance requirements from septic systems to wells, ponds, lakes and streams. Drawings do not need to be to scale but distances indicated must be accurate.

DIRECTIONS

Draw a sketch of your property on a blank or graph paper indicating location of your well, septic, ponds, streams structures, etc. It is important to indicate the following distances: Road Frontage on all lots on splits and subdivisions, Distance to new property lines from structures, sceptics, wells, etc.
